AN ACT to amend the education law, in relation to the powers of school districts to employ or contract for the preparation of records and accounts

Became a law July 28, 1966, with the approval of the Governor. Passed on message of necessity pursuant to article III, section 14 of the Constitution by a majority vote, three-fifths being present

The People of the State of New York, represented in Schate and Assembly, do enact as follows:

Section 1. Section twenty-one hundred sixteen-a of the education law is hereby amended by adding thereto a new subdivision, to be subdivision four, to read as follows:

4. The school authorities of each school district may employ or contract for the preparation of payrolls, accounts and records by persons, firms or corporations using electronic computer systems.

§ 2. This act shall take effect immediately.

CHAPTER 514

AN ACT to authorize the village of Greenport to finance certain expenditures beyond budget appropriations in certain cases and providing for the payment thereof

Became a law June 17, 1971, with the approval of the Governor. Passed on Home Rule request pursuant to Article IX, section 2(b)(2) of the Constitution, by a majority vote, three-fifths being present

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The village of Greenport is hereby authorized to pay back into its electric department depreciation fund, the amount of thirty thousand dollars, which was withdrawn during the fiscal year nineteen hundred sixty-nine-seventy in order to fund general village expenditures in excess of budget appropriations.

§ 2. The sum of thirty thousand dollars shall be paid back into such electric department depreciation fund up to and no later than June first, nineteen hundred seventy-four. The source of the funds for repayment shall be (a) general appropriation of the village and/or (b) surplus revenues of the village electric department and/or (c) notwithstanding any of the provisions of section 25.00 of the local finance law, the proceeds of the issuance of revenue anticipation notes, not in excess of thirty thousand dollars, which shall be redeemed by surplus revenues of the village electric department and which shall be renewable for periods not in excess of one year and in no event beyond June first, nineteen hundred seventy-four.

§ 3. This act shall take effect immediately.
