Chief Executive Officer's Report

Christa Zaros, Head of Community Engagement reported on 1,081 people registering for our Summer Reading Program. 81 over the goal of 1,000. The Board applauded this achievement. Our new room booking and event registration software is set to debut on Monday, August 26. Christa has been training staff, coding the software and making sure all are ready. Our new website and app will follow after this portion launches. Upcoming

events we are attending are: Hauppauge Fire Department Open House, Homecoming, and Kicks for Cancer. The farmers market is scheduled for Wednesday, August 21 and will continue through October. Additional vendors will be coming. Christa requested some additional help, four hours a week, with social media. She and the CEO are attending the Library Marketing and Communication Conference in St. Louis in November. The Sustainability, Resilience and Regenerative Committee have been meeting. The TREX bench plastic collection is a result of this groups work. They have a lot more they are looking at doing. The Chief Executive Officer shared the highest number of visits to the Library July since October 2019, in addition to more attendees to the Fridays Out Front series. The independent audit field work has begun. A discussion about the Library's next steps in developing our concept into a plan for Hidden Pond Park. The CEO recommends inviting a construction management firm to the next meeting to discuss the state of public library construction, budgeting and timelines in 2024. Catherine Berntsen, Head of Collections, Volunteers, and Staff Learning presented on how the Library can think about serving our community and visitors better, while keeping the staff safer, secure and less stressed. This, along with the CEO's compilation of incident reports, will inform the changes to procedures and training needed for staff. The CEO shared the status of hiring a new full-time person for our Children's Department.

The President will inform the absent trustee in writing that they are no longer on the Board.
